Candidates will be required to start their research work under supervisor from the date of joining. Candidate will be required to submit the registration form along with a tentative broad outline of proposed research work with all documents on or before 20th December,2009 to the Dean, PG Studies through Supervisor, Head of the University Department and Faculty Chairman. The PG Research Board meeting will be held between 20-24 December 2009 and candidates will be required to present tentative outline of his/her research proposal in the meeting. After registration candidates will be required to deposit annual college fee in the University Department concerned as per rules.

The course work will start from 1st January,2010. Regular attendance in the department during course work will be compulsory. Employed candidates will be required to submit their relieving order from their employer to join the course work. Candidates will be required to register for course work by filling a Proforma and submitting the same along with required fee (Rs 2000/-) to the Director, University Computer Centre on or before 25th December,2009. All the candidates are advised to read the Ph.D. rules and guidelines(available on website) and follow all the rules and regulations.
