### **3.4.3. Additional Information**

Office of the Dean, Post Graduate Studies of the university is responsible for all matters related to the research programme leading to research degrees D.Sc./D.Lit., Ph.D. and M.Phil. Admission, course work, registration, monitoring, evaluation and award of Ph.D. and other research degrees offered at various university departments, affiliated colleges, institutions under MOU with the university are directly dealt by the Dean. In addition, the academic reforms, R&D Cell, consultancy, research publication etc are also administered by the Dean. Ph.D. and other research degree programme are governed by following Academic and Advisory Committees:

- **Academic Council**
- **PG Research Board (PGRB)**
- **Core Academic Reforms Committee**
- **Departmental Committee**

#### **ACADEMIC COUNCIL**

Regulations related to admission, registration, progress, evaluation and award of M.Phil./Ph.D./D.Sc./D.Lit. requires approval of the Academic Council of the university. Research degrees to the successful candidates are awarded only after taking approval of the council.

#### **POST GRADUATE RESEARCH BOARD (PGRB)**

All matters relating to registration and award of M.Phil/Ph. D./D.Sc./D/Lit. will be determined and implemented by a Post Graduate Research Board consisting of the following for each subject:

1. Vice-Chancellor Chairman
2. Chairman, Faculty concerned Member
3. Senior most Professor in subject concerned Member

4. Head of the Department concerned Member
5. External subject expert Member
6. Supervisor Member
7. Dean, P.G. Studies Member Secretary

The PGRB is empowered to give the approval for recognition of supervisor as well as the centre /department /college/ institute of research for Ph. D. etc. PG research Board normally meets three to four times in a year.

### **CORE ACADEMIC REFORMS COMMITTEE**

The Vice-Chancellor has constituted a Core Academic Reforms Committee (CARC) from year 2009 as an advisory committee to recommend academic reforms to be adopted in Post Graduate courses, Ph.D./M.Phil., prepare guidelines to implement various regulations, policy decision regarding various academic matters, monitor post graduate and research programs etc.

### **DEPARTMENTAL COMMITTEE**

Admission to the Ph.D. programme is made by the Departmental Committee. The departmental committee consists senior faculty members of the Department and Head of the Department is the Convenor of the Departmental Committee.

In the case of Ph.D. programme, the Departmental Committee is responsible for following:

- Brief candidates attending Interview for Ph.D. admission about the research areas and research facilities in the department and affiliated colleges.
  - Conduct Interview for Admission to Ph.D. programme and allot supervisors.
  - Monitor Progress of Ph.D. Scholars
  - Approval of Draft copy of Ph.D. thesis of Ph.D. scholars
