Name of the Project	Differential expression of pathogenesis related protein genes in tomato treated with Alternaria alternata and its toxic metabolites
	Description : Prime goal of the research project is to characterize the pathogenesis related protein genes in tomato during treatment of <i>Alternaria alternata</i> and its toxic metabolites. To achieve this goal, project aim to culture and growth of <i>Alternaria</i> fungi and produce its toxic metabolites, then identify the metabolites by HPLC analysis. Differential gene expression analysis using RT-PCR with hybridization techniques. To study the structural characterization of protein genes involved in treatment condition. The work involves intensive wet-lab work and therefore candidate has to spent long hours to achieve the goal of this project.
