TERMS & CONDITIONS FOR THE POST OF RESEARCH OFFICER

- 1. The Consolidated compensation payable to such employees on contract will be equal to the total of (i) basic pay (including grade pay, if any) at the minimum of the scale of the concerned post, approved by the Ministry (ii) admissible HRA and (iii) admissible DA as on Ist January of the year of advertisement inviting application against the post.
