**Following points were discussed and decided in the meeting:-**

1. The minutes of last USB Meeting were discussed and confirmed.
2. The matter pertaining to relaxation in the qualification (Good Academic Record) in the appointment of Assistant Director Physical Education was discussed and it was resolved that minimum second division should be considered in place of 50% of marks for good Academic Record.
3. The proposal of starting of M.A in Yoga two year SFS course (with accordance to the UGC recommendations) from coming session was considered to get approval from the Academic council of University.
4. The proposed Budget for WZ and IZ IUT Basketball (M) for Rs. 8,65,000/- only was passed by the Board members that the expenditure will be incurred from the University Fund head of budget head \*1-UAO-xxxx-Refund of Revenue, Amount of Games & Sports Development Fee received from the regular students of the affiliated colleges with the examination fee (non Plan).


5. Under the "Other table agenda by the permission of Chair" the following were discussed:-

- The Matter of eligibility of a student for playing in the ICT of university. It was resolved that the Performa of eligibility and Photo ID Performa should be duly signed by the Incharge Sports with seal and Dean/Principal of the colleges with seal, along with institute seal.
- Any disqualification of sportsperson on the grounds of ineligibility in team games results into automatic scratching of his/her team for that academic year and the college will be penalized with Rs. 10,000/- each case and the issue will reported to the Vice Chancellor in case of Constituent colleges and to the Director, college education in case of government Colleges and the Secretary of Society/Committee in case of private College.
- In case of individual events, the ineligible candidate be debarred from the participation in any Inter Collegiate/University Tournament in future and the matter should be reported accordingly to the above mentioned for the concerned college with penalty of Rs. 10,000/- per each case of ineligible candidate.

It was also resolved the candidate should submit a declaration (Prescribed by USB) on Non Judicial stamp of Rs. 10/- for the participation in IUT.


- The Games Fee Rs. 100/- charge from the student of constituent colleges should not be send to the University Sports Board, It will remain with college and Dean of concerning college will arranged to spend this amount through Incharge sports (GF,USB) & college sports committee for Inter Collegiate sports event by their own level. The purchase of sports items & Equipments can be made through the reference of USB tenders.





1. The amendements suggested by the Committee of Courses in M A Education course were accepted.
2. The P. G. Diploma in Guidance and Counselling course was accepted as approved by the Academic Council without any further amendment.
3. On the basis of consideration of request received from students, members unanimously agreed that candidates admitted on the basis of graduation from science stream may be provided M Sc Yoga and those admitted on the basis of graduation from other disciplines may be provided M A Yoga degree.
4. Six weeks certificate course in Yoga was also approved by the members.
5. It was also agreed upon that Faculty Chairman will request to the University to create some fund for teaching faculties in Yogic courses.
6. As per directions of state government, it was instructed to include Khel darshan as one unit in compulsory paper along with compulsory subject. In this reference, it is unanimously agreed upon and decided that as recommended by the Departmental Committee and Committee of Courses, this has been approved and has been forwarded further.
