**Minutes of the Meeting**

A meeting of the Faculty of Social Sciences was held on 17.08.2019 at 12:30 pm in the Smart Room of the Department of Political Science. The following faculty members were present in the meeting:

At the outset Faculty Chairman, Prof Sanjay Lodha extended a warm welcome to all the members present in the meeting.

The Faculty discussed the following agenda items and resolved:

**Agenda Item 1: Approving the course structure and details of Bachelor of Library and Information Science and Master of Library and Information Science in CBCS**

The Faculty unanimously approved the course structure and details of Bachelor of Library and Information Science and Master of Library and Information Science in CBCS (Annexure 1). It was also resolved that these courses would begin from academic session 2019-20. In lieu of approval by the Academic Council, the approved courses may be referred to the Hon'ble Vice Chancellor for special approval to ensure that the courses start from the current academic session 2019-20.

It was also resolved that M.Lib.Sc will commence in regular mode with at least 20 seats from this session. Only after the completion of admissions on these 20 seats, students will be given admission in SFS mode. The members of Departmental and Committee of Courses of Department of Library and Information Science are approved as per the meeting held on 21.06.2019 of the same. (Annexure 1).

**Agenda Item 2: Approving syllabus amendment as approved by Committee of Courses in Departments of Economics**

The Faculty unanimously approved the revision in syllabus of MA Semester IV CBCS submitted by the Committee of Courses of the Department of Economics held on 14.08.2019

(Annexure 2). The Faculty approved the syllabus of a new paper "Public Policy in India" introduced in option with Dissertation (Annexure 3). The revised syllabus will come into effect from the academic session 2019-20.

### **Agenda Item 3: Approving the revision in examination schemes of Journalism & Mass Communication**

The Faculty unanimously approved the examination scheme already approved by the Committees of Courses held on 13.05.2019 (Annexure 4).

### **Agenda Item 4: Approving the revision in syllabus and examination scheme of diploma courses of Readymade Garments**

The Faculty unanimously approved the agenda items 1 to 4 of the minutes of Committee of Courses (Annexure 5) held on 14.08.2019 and 16.08.2019.


The Faculty deferred item no. 5 of the same. It was resolved that Faculty can approve any proposed course only after complete syllabus and examination scheme are approved by the respective Committee of Courses.


### **Any other matter with the permission of the Chair:**


1. The problems of implementing CBCS at the Master's level in Departments of University were discussed. The Faculty expressed concern at the different nature of courses and schemes of examination within the and it was unanimously resolved that scheme of programmes should be either semester or annual at all levels. If applicability of CBCS at all levels is not possible due to resource crunch or shortage of manpower then it would be better to adopt annual scheme at all levels, i.e. UG and PG in the University.
2. The Faculty took a serious note of no action being taken by the office of Registrar on the resolution already passed by the Academic Council (on May 25, 2012, minutes no. 18.c-i) and BOM to give the status of Department to Journalism and Mass Communication after the reminder given by the Faculty in the meeting of Academic Council held on 28.09.2018.
3. All the departments were invited to introduce new courses or revise syllabus in the respective departments as per the requirement. The same shall be applicable from the academic session 2020-2021.
4. In the last meeting of Faculty (10.09.2018) it was unanimously resolved that admission to the PhD program from the waiting list needs to be given only if those selected initially do not join within a certain time limit. Otherwise the remaining vacant seats need to be carried out to the next round of admissions. These minutes were passed by the Academic Council in its meeting held on 28.09.2019. The Faculty reaffirmed the existing provision which permits a candidate who has cleared the RET to reappear in the interview on not being selected once.  
The practice of giving admissions from waiting list as and when a vacancy arises was looked down upon by the faculty.


