Certificate Course On "Women and Legal Rights"

Objective of the Course:

- a) To initiate academic intervention with certificate course on Women and Legal Rights
- b) To integrate skill components to enhance employability of the students by organizing orientation lectures, interactive sessions and field visits
- c) To develop proactive role in education people about law related to women and formulate legal empowerment using legal education
- d) To intensify the practice of multidisciplinary approach in collaboration of experts from relevant departments and Schools

Locale of the study: Mohanlal Sukhadia University, Udaipur

Duration of the Course: 6 months; it includes three modules.

Applicants: 12th passed, Law Graduates, Graduate students, Post Graduate Students, Government Employees, Elected Representatives (Educational Qualification may vary in this case), Person affiliated with civil society and NGOs.

Curriculum of the Course: Course includes both practical and theory classes. Theory classes will be imparted at the centre, while practical classes will be conducted with experts from collaborated legal bodies, NGOs, or Women's Organizations and also assignments with the faculty members.

It is envisaged that the course will be instrumental for awareness regarding legal rights especially for women and mechanism to sensitize people about violence against women, marriage and family, sex related abortions, LGBTQ, Surrogacy and others women's legal rights.

Methodology: The overall approach of the course seeks to strike a balance between theory and practical. Classroom based lecture-discussions, debates, deliberations, case studies and practical exercises as well as group exercises form an integral part of the course methodology.

• Course Evaluation: Assessment will be based on Assignment (70%) and class participation (30%). There will be test and assignments after each module. A certificate will be awarded on successful completion of the course. Students must attend 100% classes and field visits. Certificates will be given only if all the components are complied with (Classes, assignments and field visits).
