The meeting started with the introduction of BOM members and administration of Oath of Preamble of the Constitution of India by the Vice- Chancellor. After rendition of "Kulgeet" of the University, the Registrar presented the item-wise agenda and the following decisions were taken and resolved:

6. To report and discuss the recommendation of the Enquiry Committee for fact finding constituted by the Vice-Chancellor to examine the case of appointment of Assistant Director, Physical Education and order of Hon'ble High Court dated 12.01.2021 & legal opinion dated 17.01.2021.

The Registrar opened and read the report submitted by the five member enquiry committee for fact finding constituted by the Vice- Chancellor under the Convenership of Prof. P.S. Ranawat. The committee in it's findings mentioned that" the selection for the post of Assistant Director, Physical Education-2018 of MLS University were wrongly made through manipulations that are evident". The letters submitted by Prof. B.L. Ahuja and Prof. Arti Prasad, part of the five members committee these two who had not signed the report were also presented. Also considered the Judgment pronounced on 12.01.2021 by the Hon'ble Rajasthan High Court, Jodhpur, disposing of the S.B. Civil Writ Petition No.10244/2020, filed by the Assistant Directors (under probation) Dr. Bheem Raj Patel and Dr. Hemraj Singh Chaudharyof Physical Education. The matter was discussed at length and looking at the seriousness of the issue it was resolved unanimously to submit the report of the enquiry committee for fact finding along with all the relevant documents including the Rajastahn High Court judgment, to the Hon'ble Chancellor for further necessary action/direction in this regard. State Government should also be informed the same. Till then the status quo of the Assistant Directors, Dr. Bheem Raj Patel and Dr. Hemraj Singh Chaudharyof Physical Education shall remain as such.

7. To consider the request of Dr. Deepak Kumar, the waitlisted candidate of Direct Recruitment 2018 seeking appointment on the post of Assistant Professor.

The house was appraised with the facts of matter as enclosed on page No.38-50 of main agenda. After approval of Board of Management in its meeting held on 25.06.2018, the offer letter for appointment on the post of Assistant Professor in Chemistry was issued to Dr. Deepak Kumar on 11 August, 2018. It was pointed out that the selection process for the post of Assistant Professor in chemistry had been completed before the issue of the UGC letter dated 19.07.2018.On the advice of Hon'ble Chancellor, the matter was referred to Advocate General of Rajasthan and legal opinion was sought from him. He submitted his report on 12.11.2018 to the Registrar by mentioning thatthe recruitment process was over much before the communication dated 19.07.2018 issued by UGC and the same was appraised to the Hon'ble Chancellor. It was also informed that the matter is also pending before the Hon'ble Rajasthan High Court.

Meanwhile the house was informed that the matter has also been communicated to the Hon'ble Chancellor and no further directions have been received till date on this matter.

It was resolved that the matter of confirmation of Dr. Tikam Chand Dakalwill be considered after the final Judgment of the Hon'ble Rajasthan High Court or the Hon,ble Chancellor as the case may be. Till then he will remain on probation.
