

7	<p>To consider the amendment in University Act/Statutes for merger/adoption of Shri Kallaji Vaidic University, Nimbahera in Mohanlal Sukhadia University, Udaipur.</p> <p>Considered the matter and HVC informed the house about the process already been completed by Shri Kallaji Vedic Vishvavidyalaya, Nimbahera and MLSU through their Statutory bodies. A proposal from "Shri Kallaji Vaidic University, Nimbahera" was received by MLSU and a combined meeting of local members of BOM of both the Universities was held on 20 July, 2021. Sponsoring Body of Shri Kallaji Vaidic University, Nimbahera also approved its willingness to merge Shri Kallaji Vaidic University, Nimbahera in Mohanlal Sukhadia University and they resolved to Repeal "Shri Kallaji Vaidic University, Nimbahera Act-20018" in its meeting of Board of Management held on 23.07.2021 in favor of MLSU.</p> <p>Surrender letter for merger / absorption of Shri Kallaji Vaidic University, Nimbahera in MLSU according to law with his entire property along with human resources to MLSU subject to certain conditions including keeping the original object of the University intact, also been submitted by the officials of Shri Kallaji Vaidic University, Nimbahera before the Hon'ble Chancellor and Higher Education Minister of the state.</p> <p>After discussion on the whole matter, it was resolved to accept the proposal submitted by the sponsoring body and Chairman and President of Shri Kallaji Vedic Vishvavidyalaya, Nimbahera for merging/ absorption etc. in MLSU as per rules and for this purpose State Government should also be requested to start the process for amendment in our University Act, as per rules and provisions accordingly.</p> <p>Further, just to compensate the loss of students of Shri Kallaji Vaidic University, it was also decided to conduct the pending examinations of students of Shri Kallaji Vaidic University, after enrolling the students in Mohanlal Sukhadia University, Udaipur as per rules.</p>
8	<p>To consider the matter of establishment of Centre of Excellence at Nathdwara.</p> <p>It was informed by the HVC that 15 acre land has been allotted by the State Government to MLSU at Dabion ka Gudha, Tehsil Nathadwara for establishment of "Shreenathji Peeth Centre of Excellence" and in the first phase of basic infrastructural development, Contouring Survey, cleaning, leveling of land and compound wall is required to be started.</p> <p>Resolved to start the process of Contouring Survey, cleaning, leveling of land and making compound wall at the place. Resolved to approve the reply submitted by the University to Higher Education Department of Rajasthan vide No. F(A/R) Estt./MLSU/Gr.II/2021/2209 dated 28.06.2021 / 01.07.2021 in the matter of Promotion from Assistant Registrar to Deputy Registrar.</p> <p>Provisions of promotion from Assistant Registrar to Deputy Registrar are not available in the University Act and no provisions are available in the University Act for promotion from one cadre to another cadre in officer's cadre. Even state Government has not framed or implemented any promotional rules for officer's cadre. The purpose of committee, constituted vide University order no F.( ) MLSU/Rect/2018/48 dated 23/24.2.2018 was to decide the qualifications only for Non Teaching posts viz-Deputy Registrar, Deputy Comptroller, Assistant Registrar, Lab. Assistant/Lab Technician etc. The meeting of the committee was held on 8 May, 2018 and the committee, recommended the qualifications for these posts but they also recommended the provision of promotion i.e. "fifty percent of total sanctioned post of Deputy Registrars shall be filled by promotion from among the eligible Assistant Registrars through an internal Selection Committee consisting of Vice Chancellor, Registrar and a member nominated by Vice Chancellor". This decision or recommendation was not in the preview of committee and was out of its jurisdiction. The BOM in its meeting held on 10.05.2018 approved the qualifications for the above post. The provision made available by the committee for such promotion was contrary to the University Act. Therefore, it was resolved to treat this provision of promotion as null and void and withdraw it with retrospective effect. The same may be informed to the State Government.</p>
