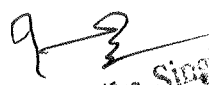
7. To discuss the matter of power lifting programme submitted by the Chairman, University Sports Board, MLSU, Udaipur.

Considered and resolved to approve the letters / orders / notifications issued by the University on Sr.No.1 and 2.

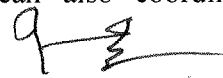
