- A. All Units/Departments must submit their Local Fund, University Fund and Self-Financing Fund position (Fixed Deposit alongwith interest) for Balance Sheet and P&L Account.
- B. Details of creating the fixed assets by some of the Departments /Faculties in the form of Construction of Buildings from Local Funds may be provided which is to be included in the books of the University.
- C. As per GST Act 2017, all the University Units/Department should deduct 2% GST TDS at the time of payment made to Vendors/Contractors etc. from the Financial Year 2023-24.
- D. Cash withdrawals should be restricted in all University Units/departments and payment should be made through online/UPI/Ac Payee Cheques only.

Resolution: Considered the matter at length and resolved that:

- A. All DDOs must strictly adhere to the directions issued by the University for compliance with Auditor's requirements and to fulfill the same by providing their Local Fund, University Fund and Self-financing Fund position (Fixed Deposit alongwith interest) for Balance Sheet and P&L Account. All DDOs will submit an undertaking every year that all the required information for preparing the Balance Sheet has been provided to the University and they will be solely responsible for the objections, if any, raised by the Income Tax Authority.
- B. All DDOs must strictly adhere to the directions issued by the University for compliance with Auditor's requirements and to include in the books of the University by providing details of creating the fixed assets by the Departments/Faculties in the form of Construction of Building from Local Fund. An undertaking will also be submitted by them that all required information has been provided including in the book of the University.
- C. Since this is a statutory requirement, all the DDOs must deduct 2% GST TDS at the time of payment made to Vendors/Contractors etc. from the Financial Year 2023-24 as per GST Act 2017 and the same will be deposited through the office of the Comptroller in time. Non-compliance with the statutory requirement is a punishable offence and the concerned DDOs will be solely responsible for the same.
- D. Cash withdrawals should be strictly restricted in all University Units/Departments and except for petty payments, contingency and examinations other than MLSU, all the payments should be made through online/UPI/Ac Payee Cheques only. Necessary order in this regard may be issued by the office of the Comptroller and non-compliance with the order may attract disciplinary action against the concerned responsible.

The order of the Govt. was discussed in detail. The orders passed by Kota Open University and <u>other</u> Universities were also discussed. It was observed by the members that as per point 08 of the order, the University employees have to deposit the amount with interest @12% whereas this condition has not been applied for employees of the Govt. meaning that both the category of employees is not treated at par.

Resolution: Considered and resolved to adopt Order No. प.13(12)वित्त (नियम)/2021 दि. 20.04.2023 received from the Planning Department, Govt. of Rajasthan regarding implementation of Old Pension Scheme concerning state undertakings/autonomous bodies/Universities etc., where NPS was applicable or no scheme was applicable, and where CPF/EPF scheme was applicable.

It was also resolved that a letter may be sent to the Govt. to treat the employees of the Government and university at par and whatever rules applicable in this matter on the Govt. employees may be made applicable to university employees till the decision is made by the Govt. in the matter, the condition for depositing the amount up to 20.06.2023 with 12% interest may be kept in abeyance.

It was also resolved that govt. maybe requested to allocate a budget for making payment of pension to those who have been appointed on or after 01.01.2004 and going to retire because the University is already facing hardship in making payment of pension to the existing pensioners and it would not be possible for the University to make the payment to these new pensioners.
