An emergent meeting of the Council of Deans called on 27.10.2023 to discuss and finalize various issues related to the forthcoming NAAC visit scheduled from 6th to 8th November, 2023. The following important points were discussed and resolved as under:-

1. Discussed and reviewed the progress of work entrusted to various committees and the house noticed that the progress is up to the mark and the remaining work is to be done on priority.
