2. During the registration, the candidate will be required to upload his/her photograph and signature.
3. After successful registration, the candidates are required to submit the requisite entrance fee i.e Rs. 850/- (Eight Hundred Fifty Only) for General/EWS/OBC(NCL)/MBC(NCL)

candidates and Rs. 600/- (Six Hundred Only) for SC and ST candidates through online payment gateway.

4. No other mode of payment of fee shall be accepted.
5. After successful submission of fee, the online payment invoice will be generated.

IV. APPLICATION PROCESS:

7. The Candidate is required to fill the Application Form for MLSULET-2024 on mlsu.ac.in and complete the registration. It is necessary to create an Academic Bank of Credits (ABC) ID from Digilocker before starting the registration.
8. During the registration, the candidate will be required to upload his/her photograph and signature.
9. After successful registration, the candidates are required to submit the requisite entrance fee i.e. Rs. 850/- (Eight Hundred Fifty Only) for General/EWS/OBC(NCL)/MBC(NCL)

candidates and Rs. 600/- (Six Hundred Only) for SC and ST candidates through online payment gateway.

10. No other mode of payment of fee shall be accepted.
11. After successful submission of fee, the online payment invoice will be generated.
12. There is no requirement to deposit the hard copy of the online application form before the date of counseling. However, the candidates need to keep a print-out of the online payment invoice and the complete application form as the same will be required at the time of counseling.

Note:

The candidates are advised to check and verify the application form before final submission. No Change in application form is permissible after the final submission. Incomplete forms and forms without fee payment will be rejected without any correspondence.

V. POINTS TO BE NOTED WITH RESPECT TO ENTRANCE TEST

11. Admission to the LL.M. (Two Year Course) shall be strictly on the basis of merit secured in the MLSULET-2024 based on the marks scored and cut-off within respective category which shall be published on the website as per the schedule.
12. The Entrance Test is scheduled to be held on **7th July, 2024 (Sunday) from 11:00 AM to 01:00 PM (2 Hours). Reporting time shall be 10.00 am.**
13. Examination Centers will be only in Udaipur. The information of Examination Center and Roll Number will be given on Admit Cards which will be made available on the website as per schedule.
14. The entrance test shall have 100 Objective Questions carrying one (1) mark each. There will be no negative marking.
15. The Candidate shall use only Blue/Black Ball point pen during the entrance examination.
16. After completion of entrance test, the candidates can carry Question Booklet with them.
17. No candidate will be permitted to enter the examination hall without the admit card and a valid Original photo ID card (Aadhar Card/Voting ID/Driving Licence).
18. The candidates will not be allowed to enter in the Examination Hall after ten minutes of the commencement of the Examination.
19. Carrying Mobile Phone in the examination hall is strictly prohibited. If any objectionable material is found, then action will be taken under Unfair Means as per University Rules.
20. Totally blind candidates must arrange amanuensis on their own and should carry attested copies of the certificate declaring the need for the same. Moreover attested copies of Marks Card/Certificate and Photo Identity of amanuensis who should not be qualified more than 10+2, be also submitted to the Superintendent of the Entrance Test Centre.

VI. ANSWER KEY AND GRIEVANCE REDRESSAL

4. The Answer Key pertaining to MLSULET-2024 shall be published on the University website as per the schedule.
5. Any objection with reference to Answer Key/Questions in the MLSULET-2024 may be submitted through mail on mlsulet@mlsu.ac.in or in writing personally delivered to the

Convener, MLSULET- 2024, University College of Law, MLSU, Udaipur as per the schedule.

6. The grievances must include the roll number of the Candidate in the subject and any objections raised must be substantiated through the source of the objection. Grievances lacking these requirements and received beyond the scheduled time shall not be entertained.

VII. CONDITIONS FOR ADMISSION

8. The candidates need to keep a print-out of the **online payment invoice** and the **COMPLETE application form** as the same will be required at the time of counseling.
9. They need to carry following **original documents and their two photocopied and self-attested sets** at the time of Counselling-
 - (g) X, XII and **all** mark-sheets of U.G. Law programme
 - (h) Gap Affidavit (if applicable)
 - (i) Transfer Certificate (in original) (Not required for non-Collegiate (Private) students)
 - (j) Migration Certificate (in original) (if the last degree is from University other than MLSU)
 - (k) Caste Certificate (In case of OBC/MBC-NCL this certificate must not be older than one (1) year from the date of admission)
 - (l) Certificate for availing the benefit of special categories (Economically Weaker Section/ Specially Abled Person/ University Wards/ Ex-Serviceman/ Kashmiri Migrant)
10. Fee has to be deposited at the time of final admission on the date of Counselling itself.
11. Once the student has been selected for admission and he assents to the same during admission, Affidavit in tune of Anti-Ragging policy needs to be submitted by him and his parents.
12. The students need to maintain attendance as per the BCI norms and have to compulsorily wear the uniform as prescribed by the College whilst attending the classes.

Candidates must note that if a question is marked with multiple answers the answer will be considered as incorrect and 0(zero) marks will be awarded for the same. **There will be no negative marking.**
