- 1. Considered confirmation of minutes of the meeting of COD held on 29.3.2008. Resolved to confirm the minutes of the meeting of COD held on 29.3.2008.
- 2. Considered proposal of Head, Department of Geology for introducing M.Sc. in Geoinformatics & Remote Sensing as a regular course of University and also his request for providing Rs.21.50 lacs as seed money. After having considered various related dimension of issues. It was resolved that the course be started as a Self Sufficient Course with 25 seats and 5 payment seats, the necessary amendments in the earlier resolution passed by the Academic Council may be got issued under the special powers of the Vice-Chancellor under 12(6) of the M.L. Sukhaida University Act.

Other issues regarding course contents and fee may be got finalized in the light of the Course being run in the M.D.S. University, Ajmer after following procedure and deliberations in the meeting of the Staff Council/Committee of Courses/Faculty. The Course be started from the session 2008-09 and proposal for required mobilization advance may be sent to the Comptroller for sanction. To start with the infrastructure facilities of Computer Lab etc. may be shared with the Lab. of B.C.A. at Science College Campus.
