At the outset the Hon'ble Vice-Chancellor extended a hearty welcome to all the members of the COD including invitees.

1. With reference to resolution No.3 of the COD held on 28.5.2008 and subsequent resolution No.6 of the Board of Management held on 18.6.2008 reviewed the matter regarding deploying teachers on contractual basis on fixed amount against the sanctioned vacant posts of Professors, Assoc.Professors and Asstt.Professors in the light of the letter No.P.14(10)Edu.4/2001 dated 9.7.2008 in connection with reservation policy and resolved as under:-2

- i) As decided earlier contractual teachers were to be deployed against the vacant posts of Professors, Assoc.Professors and Asstt.Professors on the minimum pay scale of Asstt. Professor minus Rs.50/- i.e. Rs.7950/- p.m. (fixed) till the post of Professors and Associate Professors are filled in on the basis of the policy being followed in the State Govt. vide No.F.1(70)/Estt/अ.क.सि./2006/224 dated 26.7.2007. This circular be modified as follows -
 - a) In the qualification, the M.Phil degree for treating eligibility be deleted.
 - b) The provision for deducting marks in case of III divisioners be deleted and only "Good Academic Record" i.e. throughout second class from secondary to degree, be implemented with the provision of relaxation for SC/ST candidates.
 - c) The provision of age limit be removed.
 - d) While determining merit additional credit of ten marks for performance in interview should be added to the prescribed criterion.
 - e) Pursuant to letter of the State Govt. dated 9.7.2008 reservation be given as per the policy of the State Government.


The proposed amendments in the State Government order be placed before the next meeting of the Board of Management for final approval.


Further resolved that pending final decision for deploying contractual teachers against the vacant posts, the Deans of the Colleges be authorized to engage Guest Faculty on payment of period basis from the panel of the last year.

2. Considered the request of the Dean, College of Law, Udaipur for relaxation in the fee i.e. Rs.8000/- p.a. inclusive of local fund for LL.B Three Year Degree Course under self financing scheme.

Resolved that the total fee of Rs.8000/- p.a. including local fund fee be charged from the students of LL.B. Three Year Degree Course under self financing scheme from the academic session 2008-09.
