At the outset, the Comptroller extended a hearty welcome to all the members present in the meeting. The following business/items were taken up with the permission of Chair:

01. To consider confirmation of the Minutes of the last COD held on 27.04.2017.

Resolved to confirm the minutes of the last COD meeting held on 27.04.2017 with the following modifications:

The Self finance Course at Arts College is being started from this session and the norms of the course will be at par with the other constituent colleges of the University.

Regarding implementation of CBCS Syllabus:

It was resolved that the CBCS syllabus will be implemented from current session and order will be issued under power 12(6) of the Hon-ble Vice-Chancellor and same will be got approved in the next Academic Council.

02. To consider recommendation of the committee constituted for utilization of Local Fund of the Constituent Colleges of the University:

Considered the recommendation of the committee and resolved that the fee collected in respective head from the students be spent for the purpose for which fee is collected during the Academic Year (1st July to 30th June). If there is any exigency to exceed the amount than the receipt in particular head the expenditure can be met out of previous surplus fund with the prior permission of the Hon'ble Vice-Chancellor.

The saving of all the heads of the Local fund as of 30th June should be informed to the Comptroller, MLSU immediately after completion of Academic Year. The details of balance of the Local fund (including all the items) as on 31st March, 2017should be informed to the Comptroller, MLSU. The details of FDRs created by the respective units be sent to the Comptroller at the earliest.

The surplus of Local Fund will be kept by the concerning colleges for 5 years and there after balance if any, shall be transferred to the University Development Fund.

The Hon'ble Vice-Chancellor desired that the cash-book and other accounts may be maintained properly to avoid the audit objections. The backlog has to be over with in three months.

03. To consider Office Note from V.C. Secretariat regarding follow-up of Niti Aayog:

Consider the office note and it was resolved that to develop partner state – may be Goa. Five-six activities may be identified. It was proposed to organize Educational tours of University Students, holding cultural week, sports competitions and quiz competitions. For coordinating Kashmiri Students the university has already set up a cell which will take care of grievances and issues of the Kashmiri Students. It was also decided that departments should constitute study group and undertake such research projects. The research projects that are being undertaken in the university should be based on the Tribal Areas and of relevance to government. It was decided that the research work/projects be made available on the university web site. Seminar regarding GST be also organized. The involvement of youth below 30 years in the academic activities like organizing debates and to hold Saturday Seminars across the state be organized and a panel on subjects and indentify experts who can speak on relevant issues be prepared. These persons can be hired on good remuneration. Five marks for cultural/youth events be fixed.

04. To consider establishment of Placement Cell in the university.

Consider the matter and it was resolved that as per Governor's Secretariat letter No.3801 dt.15.5.2017 a placement cell has been established in the university. The process for appointment of Placement Officer is under way.

05. To consider e-mail received from Dr.Prakash Chandra Jain regarding water recharge.

Considered the matter and it was resolved that all the wells/step-well and hand pumps in the university campus be recharged. It was also decided that Dean/Directors will check the wells and roof net-working for recharge the water level. The project of 10,000 tree plantation be taken up which shall be helpful in water recharging. The plantation programme should be completed well within this rain season only.

06. To consider the office note submitted by the Dean, PG Studies regarding revision of remuneration rates for Ministerial Staff and Peon

Considered that payment of remuneration to Ministerial Staff and Peon for the Ph.D course work and it was resolved that the previous rates of Rs.1500/- to ministerial staff and Rs.800/- to peon be revised as (1) Coordinator - Rs.5,000/-, (2)Ministerial Staff - Rs.3, 000 and (3) Peon - Rs.2000/-.

2. To consider letter dated 10.08.2017 received from the Dy. Secretary (TE), MHRD, Deptt. of Higher Education, GOI, New Delhi regarding the Action Plan 17-by-17 to be achieved by all the Vice-Chancellors by December 2017.

- (iv) Regarding tuition fee, the Dean, College of Science will prepare a detailed note and get it approved in the next COD.
- 4. To consider letter No.F.1(17)(I)RB/2017/6201 dated 09.08.2017 received from the OSD(Hr.Edu.), Governor Secretariat, Jaipur regarding to send information about (i) the introduction of Ethics and Disaster Management in the syllabus, and (ii) declaration of examination results in time.

After discussion on the letter it was resolved to (i) make it a part of syllabi and the Dean, UCSSH and the Dean, UCoS will prepare course curriculum for inclusion of Ethics in the syllabus and for Disaster Management respectively and get it approved in the next COD.

Technician, UCoS, it was resolved that the University Clean Consumer Loan may be granted to him and such other employees as per existing rules after obtaining guarantee from two regular employees who were appointed prior to 01.01.2004 and having Provident Fund with the University and the counter guarantee of the Dean, UCoS and concerned Deans respectively.

- 2. The matter regarding non transfer of games fee to the concerned college has been raised by the Deans and it was resolved that the games fee deposited by the students with other fee at the time of admission may be transferred to the respective College immediately by the Comptroller and compliance report may be put up in the next COD.
- 3. Regarding remedial coaching classes, it was resolved that there will be no remedial coaching classes from the current academic year 2017-18 and after obtaining detailed opinion from the COE, the respective Deans will notify the same to the students in regular interval.
- 4. The Comptroller informed the COD that bill for receipt of revenue are not generated though IUMS and because of this, delay occurs in preparing Balance Sheets and other information. After discussion in detail, it was resolved that (i) bill for receipt of revenue will be generated through IUMS portal with immediate effect by the colleges; and (ii) all Deans & Directors will submit information about the amount of funds lying with them unutilized under Local Funds & SFS Courses.

It was also decided that a workshop for Deans, Directors and associate staff of the colleges will be organized by the Comptroller to provide information about the University accounting procedure.

- 5. The matter regarding some changes in the formats of degree and design etc in the degrees for the examination year 2016 has been discussed and resolved that:
 - (i) Same fonts as of degree 2015 be continued but the size of fonts should be reduced;
 - (ii) Optional Subjects wherever mentioned may not be mentioned from 2016;
 - (iii) Some more information may be added in QR code in comparison to the degree of 2015; and
 - (iv) The design and colour of the boundary may be changed with printing of University name in English in red colour.

It is further resolved that printing of degrees for the examination year 2016 may be started with above modifications and the same may be reported in the next meeting of the Academic Council.

- 6. on furnishing a certificate from the controlling authority to the effect that the official journey had to be cancelled due to official reasons or unavoidable circumstances beyond the control of Government servant like sudden illness or death of near retalive etc. The ordinary reservation fee in such cases may also be reimbursed to the Government servant without waiting for the acceptance of his claim for refund of cancellation charges by the Railways. Road Transport or Airline Authorities. Refund of Agency charges paid to a travel agency for booking journeys for his own convenience are not to be made. The cancellation charges shall be claimed in the Travelling Allowance Bill.

In unavoidable circumstances beyond the control of Government servant, the reservation fee or unused tickets cannot be produced for claims or cannot be cancelled by concerned airline authority, in such cases, Competent Authority as per Item No. 3 of rule 25 (2), shall be competent to reimburse the reservation fee / ticket charges, after fully satisfying with the circumstances and relevant documents.

4. Gunman accompanying a Minister while on tour may travel by rail in the Class the Minister is travelling, if, so desired by the Minister. He shall be entitled to rail fare accordingly, subject to recording of following certificate.

"Certified that I have travelled in the same Class and compartment in which the Minister has travelled.

5. Railway Magistrate, Officers and men of Railways Police Force who are entitled to a free pass under the Free Pass Rules of the Railways for making journey on tour by rail are not entitled to claim rail mileage allowance at the rates prescribed in this Appendix. However if he is required to undertake journey on duty by road in continuation of rail journey he shall be entitled to claim road mileage allowance in addition to daily allowance admissible under these rules provided he travels by road to a place at a distance exceeding 15 kms from the rail point or returns thereto from a distance exceeding 15 kms.


