While considering the requests of some of the candidates who could not qualify in the recent empanelment process, the Vice Chancellor is pleased to direct SFAB to conduct one more Job Test latest by 31st May, 2019 in all the categories giving a chance to those candidates who applied earlier but either could not qualify or remained absent to appear in the Job Test conducted between 04.03.2019 to 07.03.2019

The Vice Chancellor is further pleased to order that those persons who were engaged as service consultants in various services till 30.03.2019 and could not meet the prescribed qualifying standards of the Job Test conducted between 04.03.2019 to 07.03.2019 shall be permitted renewal w.e.f. 01.04.2019 till the process of new Job Test is completed on the following conditions:


- (i) The concerned Course Coordinator/Course Director/DDO has to verify satisfactory performance of such persons;
- (ii) The person concerned shall have to improve his performance and meet the prescribed qualifying standards in the empanelment process (Job Test & Aptitude Test) to be conducted by SFAB latest by 31st May, 2019 or failing which the permission of renewal of engagement shall stand cancelled automatically with immediate effect; and
- (iii) This shall not set any precedent for future empanelment.

On the recommendation of the concerned Course Coordinator/Course Director/DDO, the administrative and financial approval/sanction for such service consultants will be issued by the office of the Registrar / Comptroller and then renewal of engagement will be made by the concerned Course Coordinator/Course Director/DDO accordingly.
