NOTIFICATION

It is notified for the information of those candidates who have earlier applied online for empanelment as Service Consultant for various categories under Self Financing Advisory Board of the University with reference to notification No. SFAB/MLSU/2018-19/367 dated February 01, 2019 and qualified the Job Test but either could not qualify the Aptitude Test or remained absent to appear in the Aptitude Test conducted between 12.03.2019 to 15.03.2019, that as directed by the Vice Chancellor, one more Aptitude Test will be conducted for them, latest by 30th June, 2019 with those candidates who qualify the Job Test conducted between 01.05.2019 to 09.05.2019 thereby giving a chance to them to qualify the process of empanelment.

Such candidates are further informed that :

- (a) Venue as notified on University website vide office order No. 389 dated 01.03.2019 (consolidated schedule for Job Test & Aptitude Test) will remain the same. For date and time of the Aptitude Test, schedule will be uploaded separately soon on the University website www.mlsu.ac.in.
- (b) Qualifying marks for Job Test and Aptitude Test individually are 40%. Marks obtained in Job Test & Aptitude Test will be counted for determining their final order of merit and recommendation for empanelment. Candidates qualifying in the Job Test (conducted between 04.03.2019 to 07.03.2019 & 01.05.2019 to 09.05.2019) will only be called for Aptitude Test.
- (c) Candidates will be permitted provisionally to appear in the Aptitude Test assuming that they fulfil the required qualifications etc. as per the norms contained in the earlier notification. In case the candidate is found to be not eligible at any stage or has submitted wrong information, his/her candidature will be rejected.
- (d) Hard copy of application with self attested copies of the caste/category certificate, educational and technical qualifications and experience etc. will be required to be submitted at the time of Aptitude Test. In absence of the same, the candidate will not be permitted to appear in the Aptitude Test.
- (e) Candidates are required to reach at the venue before one hour of the schedule of Aptitude Test and bring all original documents for verification with one colour photograph and ID proof.
- (f) The Aptitude Test shall be based on personal interaction with the candidate by the committee.
- (g) An SMS will be sent to the candidates for date and time of Aptitude Test at least one day in advance .
