At the outset, the Comptroller extended a hearty welcome to all the members present in the meeting. Later on, with the permission of the Chairperson, the house started its business and following items of the agenda were discussed and resolved.

1. To confirm the minutes of meeting of the Council of Deans held on 06.09.2019.

Resolved to confirm minutes of meeting of the Council of Deans held on 06.09.2019-except the matter related to students election.

2. To consider:

(i) EWS student's outright admission letter from Mukul Menariya & Dev Somi and Order No.4458 dated 18.07.2019.

Considered and resolved that for implementing EWS student's admission, in this connection copy of the documents from the Government of Rajasthan, Jaipur be obtained and the same may be implemented in the University.

- (ii) RTPP Act Considered and resolved that RTPP Act will be strictly followed in the University.
- (iii) REPSAR Act Considered and resolved that for recruitment of all the posts (teaching /non-teaching Class-IV), the qualifications and pay scales will be at par with the State Government employees now onwards.
- (iv) Local Fund Audit Considered and resolved that local fund audit should be mandatory for all the units and a no dues certificate be obtained from the concerned Unit Incharges/DDOs at the time of their retirement. In future, fixed deposits will be made in the nationalized banks only.
- (v) Affiliating Colleges Considered and resolved that extension for affiliation will be made after compliance of the following points:
 - a. The college must have their own website.
 - b. They should have Principal and required number of teaching faculty.
 - c. The college should adopt one village.
- (vi) Energy Audit Considered and resolved that for maintaining the consumption of electricity, solar panels be installed in all constituent colleges. Energy Audit be conducted by the same committee constituted in University College of Science.
- (vii) All India Higher Education Integrated Portal Considered and resolved that Dr. Avinash Panwar, Director, Computer Centre was authorized to upload all data on All Indian Higher Education Integrated Portal.
- (viii) Centre of Excellence Considered and resolved that a detailed proposal in this regard be prepared and sent to the Government.
- (ix) National Innovation and Start Up Policy, 2017 Letter be prepared and sent to all industrialists in the nearby areas.
- (x) 01% of the University Budget should go for University Incubation Centre -Considered and resolved that an allocation of Rs.50 lakhs will be made in the next budget for University Incubation Centre.
- (xi) IPR Cell Considered and resolved that experts be invited from Delhi/Ahmedabad etc.

Considered and resolved that Ph.D. joining fee and thesis submission fee be reduced from Rs.10,000/- to Rs.8,000/- and from Rs.25,000/- to Rs.18,000/- respectively subject to approval of BOM.

 To consider letter No.F.MLSU/Clean/2019/141 dated 13.11.2019 regarding insurance scheme for the University employees (loanee) who are recruited on or after 01.01.2004 for covering the risk of the outstanding loan in the death cases or any other of the University employees.

Considered and resolved that the University employees who are recruited on or after 01.01.2004 desired to take House Building Loan or Clean Loan and already taken the loan, they must get the insurance cover from LIC or any other Insurance Company.
