

7. To report various letters/orders issued by the University(Sr.No.1 to 5).

Considered and resolved that for maintaining quality control, a Quality Control Committee for construction/repair work consisting of following members is constituted:




1. Prof. P.K. Singh, Dean, UCCMS – Convener
