- In case, affiliation letter is issued to the college and on the request of the concerned college for carry forward of fee with the reasons of 'Zero' session or students not admitted and any other similar reason(s), then inspection fee, application form fees and late fee deposited, (if any), will be deducted from the total amount deposited and remaining amount will be adjusted / carry forwarded.
- In case, affiliation letter is not issued to the college but the inspection has been done by the 2. committee constituted by the University, then inspection fee, application form fees and late fee deposited, (if any), will be deducted from the total amount deposited and remaining amount will be adjusted / carry forwarded.
- In case, affiliation letter is not issued to the college and inspection has also been not dome. 3. then application form fees and late fee deposited, (if any), will be deducted from the total amount deposited and remaining amount will be adjusted / carry-forwarded.
- In case of application is submitted under any scheme or specific scheme of the Govt. and 4. NOC is not received/issued from/by the Govt./agencies or inspection is not done by the University or affiliation letter is not issued to the College or any such other reason(s) and on the request of the concerned college for not to run such course(s) and refund of amount, then application form fees and late fee deposited, (if any), will be deducted from the total amount deposited and remaining amount will be adjusted / carry forwarded or refunded as the case may be.
