- 2. Premium per student willbe Rs. 6.00 (Rs. Ten) only inclusive of all Taxes.
- Local representative of the insurance Company at Udaipur will service the policy during its tenure.
- 4. Coverage:
 - (a) Compensation of INR 1,00,000 (INR One lac) to student of MLSU, in case of accident Resulting in death, due to including but not limited to reasons like Vehicle accident, Accidental falling Drowning Electrical Shock, Frost bite, Snake bite etc.
- (b) Compensation of INR 1,00,000 (INR One lac), in case of accident resulting in Permanent Total Disablement (i.e.loss of two eyes or two limbs or one eye & one limb)due to reasons mentioned above.
