CPR was introduced as a new code of procedure at the time of its enactment in 1999. Since this time, it has evolved as being the first in a continuing program of amendments to litigation rules, of which it has played a major part.

In 1988 the Civil Justice Review (CJR) was undertaken in order to identify defects in the current civil law system. Expense, delay and complexity were named as the main problems. REF. Heilbron & Hodge (1993) agreed with the CJR and stated in their report that there was a need for a radical change of culture in the way that litigation was conducted, and that it was in urgent need of reform.

Innovations followed these reports but the problems continued. This led to Lord Woolf being appointed in

1994 to review and potentially reform the civil procedure system. He then produced two reports entitled 'Access to Justice' and these provided the foundations for the serious amendments introduced in April 1999.
