The University do here by agree that if the approved service provider duly provide the said service the manner aforesaid, observe and keep the said terms and condition ,the University will make payment to the approved service provider at the time and the manner set in the work order appended with this agreement. The mode of payment will be as specified below.
6. 100% payment through crossed cheque against satisfactory implementation and operation of the service.
7. The implementation of the prescribed services shall be affected from within 15 days from the date of purchase order.
8. Wherever applicable The Approved service provider shall provide prescribed services by deploying their staff as per work description given in the work order. The approved supplier shall be responsible for making payments for their staff including provident fund, medical insurance and other applicable welfare charges from their business bank accounts and the university shall not of be liable for payment of these charges to the staff deployed by the approved supplier.

9. Wherever applicable the approved service provider shall be responsible for any damages to the university due to non-performance in the services described in the work order
10. If the service provider fails to provide services as prescribed in the work order, the penalty as prescribed in the work order will be paid to the University by the service provider

11. All disputes arising out of this agreement and all question relating to the interpretation of this agreement shall be decided by the Vice-Chancellor, Mohan Lal Sukhadia University, Udaipur the decision of the Vice-Chancellor, Mohan Lal Sukhadia University, Udaipur shall be Final.
