Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. **Bid Estimated Value 400,000/- (Four Lakhs Rupees Only)**
2. **EMD 2% of Tender Value in the form of DD in favour of the Course Director, Informatics & Computational Sciences and Programme MLSU, Udaipur.**
3. The successful Bidders shall be required to deposit an amount of performance security equal to 5% of the tender value in the form of DD/FD in favour of the Course Director, Informatics & Computational Sciences and Programme, MLSU, Udaipur and execute an agreement with the University on a non judicial stamp of Rs. 500/- for supply of material as per bid rules. The performance Security deposit shall be refunded after one year of the expiry of the agreement/contract subject to its successful completion to the satisfaction of the purchasing officer.
4. Certification is mandatory for Technical Fit.
5. The Procuring Entity is not bound to accept the lowest Bid and may reject any or all Bids without assigning any reason thereof.
6. Bidders should submit compliance sheet on letterhead.
7. Bidder will have to give a presentation on PoC (Proof of Concept) before opening of financial bid.
8. The Supply should be Complete within 30 days, from the date of issue of Purchase Order.
9. Payment will be made only after proper supply, installation and commissioning of the item.
